Why Choose Adoption?

Answers to your questions

Who will help me understand this decision and deal with my feelings?

Your counselor at Adoption Choices will help you process your concerns. We will help you make sure that your decision is sound and informed, based on the facts about adoption. It is natural to be very emotional about this decision, and to have conflicting feelings.

Can I choose the family for my baby?

Absolutely. You can select the family you would like to make an adoption plan with and decide what level of contact is appropriate for you. We will help you make a adoption plan that fits your needs.

How much contact will I have with the adoptive family?

The adoption process includes a variety of openness options for you. Your adoption may be fully confidential (closed), have limited contact (semi-open), or have full and free contact before and after the adoption (fully-open). Your counselor will help you understand what options may be best for you.

How are adoptive families chosen?

Once you discuss your preferences with your counselor, we will provide screened families which meet your criteria. You will receive profiles of the families which will tell you about the families and their lifestyles.

How do I know the family will provide a good home?

All adoptive families working with Adoption Choices are carefully screened and background checked by an adoption counselor or social worker to make sure they will be healthy, safe, loving parents.

Can I make an adoption plan without the father?

If the father doesn't wish to participate in the adoption plan, or if he can't participate for any reason, your counselor will discuss the options for dealing with his possible parental rights and moving forward with the adoption.

Will I have contact with my baby at the hospital?

You may have as much or as little contact with the child at the hospital as you would like. Your counselor will help you explore your options for how you would like things to go at the hospital.

Can you help me with my rent, groceries, or medical care?

Yes we can. We are able to provide support to meet your needs, and to help you get signed up for Medicaid or to pay out-of-pocket costs of your private insurance. Your counselor will help you assess your needs and resources.

Will I have to go to court?

Usually you will not have to go to court at any time. You may sign paperwork forty-eight hours after the baby is born that allows the adoption to happen, and Adoption Choices will go to court for you.
